American Association of University Professors (AAUP)

Dependent Child Tuition Waiver

A waiver of tuition for dependent children who are enrolled in an undergraduate degree program at the University of Connecticut.

Employee Spousal Tuition Waiver

A waiver of tuition for the spouse of an AAUP member who is enrolled in an undergraduate degree program at the University of Connecticut for non-laboratory courses on a space available basis.

Employee Tuition Reimbursement

Reimbursement of tuition charges (paid for by employee) for courses taken at the University of Connecticut or another accredited institution.

Management/Confidential

Dependent Child Tuition Waiver

A waiver of tuition for dependent children who are enrolled in an undergraduate degree program at the University of Connecticut.

Employee Tuition Waiver

A waiver of tuition for employees in undergraduate and graduate, non-laboratory courses on a space available basis at the University of Connecticut.

Employee Spousal Tuition Waiver

A waiver of tuition for the spouse of a Management/Confidential employee who is enrolled in an undergraduate degree program at the University of Connecticut for non-laboratory courses on a space available basis.

Employee Tuition Reimbursement

Reimbursement of tuition charges (paid for by employee) for courses taken at the University of Connecticut or another accredited institution.

University of Connecticut Professional Employees Association (UCPEA)

Dependent Child Tuition Waiver

A waiver of tuition for dependent children who are enrolled in an undergraduate degree program at the University of Connecticut.

Employee Tuition Waiver

A waiver of tuition for employees in undergraduate and graduate, non-laboratory courses on a space available basis at the University of Connecticut.

Employee Tuition Reimbursement

Reimbursement of tuition charges (paid for by employee) for courses taken at an accredited institution, other than UConn, or for University of Connecticut summer course work. Tuition reimbursements ONLY cover applicable tuition charges. An UCPEA reimbursement rate is determined each semester, and is based on the number of employees participating in the program each semester.

Administrative Clerical (AFSCME) NP-3

Employee Tuition Waiver

A waiver of tuition for employees in undergraduate, non-laboratory courses on a space available basis at the University of Connecticut. Limited to two courses per semester.

Employee Tuition Reimbursement

- Reimbursement of tuition charges (paid for by employee).
- 18 credits per Fiscal Year.
- \$1,200 per Fiscal Year.
- Reimbursed at \$115 per credit for undergraduate courses and \$145 per credit for graduate courses.

Maintenance & Service Unit (CEUI) NP-2

Employee Tuition Reimbursement

- Reimbursement of tuition charges (paid for by employee).
- Reimbursed at 75% of the UConn rate for undergraduate and graduate courses.
